

# 2024 Winter Convention Portland, Oregon

### **RESOLUTION #24 – 04**

## "ENDORSEMENT OF THE SCALING COMMUNITY LENDERS ACT OF 2023 (S. 1442)"

#### **PREAMBLE**

We, the members of the Affiliated Tribes of Northwest Indians of the United States, invoking the divine blessing of the Creator upon our efforts and purposes, in order to preserve for ourselves and our descendants rights secured under Indian Treaties, Executive Orders and benefits to which we are entitled under the laws and constitution of the United States and several states, to enlighten the public toward a better understanding of the Indian people, to preserve Indian cultural values, and otherwise promote the welfare of the Indian people, do hereby establish and submit the following resolution:

**WHEREAS**, the Affiliated Tribes of Northwest Indians (ATNI) are representatives of and advocates for national, regional, and specific tribal concerns; and

**WHEREAS,** ATNI is a regional organization comprised of American Indians/Alaska Natives and tribes in the states of Washington, Idaho, Oregon, Montana, Nevada, Northern California, and Alaska; and

**WHEREAS,** the health, safety, welfare, education, economic and employment opportunity, and preservation of cultural and natural resources are primary goals and objectives of ATNI; and

**WHEREAS,** the Native CDFI Network (NCN), founded in 2009, is the only national member coalition of the Native community development financial institutions (CDFI's) in the country, representing 64 certified Native CDFI's and two dozen more emerging Native CDFI's in Treasury's certification pipeline; and

**WHEREAS,** the NCN has requested policy support for an important piece of legislation called the Scaling Community Lenders Act of 2023 (S. 1442) to be considered by the United States Senate during the 118<sup>th</sup> Congressional session; and

**WHEREAS,** the proposed legislation activates and funds the long-dormant Section 113 of the Riegle Act—the CDFI liquidity enhancement program—which would allow the Treasury's CDFI Fund to create pilot projects to attract new capital to the CDFI industry; and

WHEREAS, the proposed legislation redirects \$100 million in dividends from the Emergency Capital Investment Program to pilot a liquidity facility at the CDFI Fund; and

**WHEREAS**, the Emergency Capital Investment Program is already authorized under the Reigle Act but never received a funding appropriation; and

**WHEREAS,** the Native CDFI Network is among a broad coalition of national organizations and partners in the CDFI, banking, and related industries supporting this vital legislation; and

**WHEREAS**, the ATNI Economic Development Committee reviewed this resolution and approved advancing these for the ATNI General Membership's consideration; now

**THEREFORE, BE IT RESOLVED,** that ATNI approves of and supports the Scaling Community Lenders Act of 2023 (S. 1442) as presented and subsequent legislation; and

**BE IT FINALLY RESOLVED,** that ATNI will rely on the Northwest Native Lending Network and the ATNI Economic Development Corporation to provide periodic reports and updates to the ATNI Economic Development Committee and ATNI General Membership.

### **CERTIFICATION**

The foregoing resolution was adopted at the 2024 Winter Convention of the Affiliated Tribes of Northwest Indians, held at the Hyatt Regency, Portland, OR, January 28 – February 31, 2024, with a quorum present.
